With XProtect Mobile you can conveniently view video from your XProtect® system from almost anywhere on your smartphone or tablet. Developed and designed by Milestone, XProtect Mobile is a free application that works seamlessly with all XProtect video management software (VMS) products and is available as a download from the Android™ Market and the App Store™. With instantaneous access to video from your XProtect surveillance system from almost anywhere around the globe via Wi-Fi, 3G or 4G connections, you can view and playback video from multiple servers and connect to cameras from different sites, helping you see what's important to you.

Support for iOS

In addition to Android support, XProtect Mobile 1.0 now also supports iOS, enabling you to view and playback video from your XProtect system on Apple® devices running iOS5 and higher, such as an iPod® Touch, iPhone® or iPad®.

XProtect Mobile licensing

XProtect Mobile is not licensed and is a free application that can be downloaded and installed on any number of servers and devices.

XProtect Mobile 1.0 can be installed on any device, such as smartphones or tablets, running the operating system Android 2.2 or higher or iOS 5 and higher.

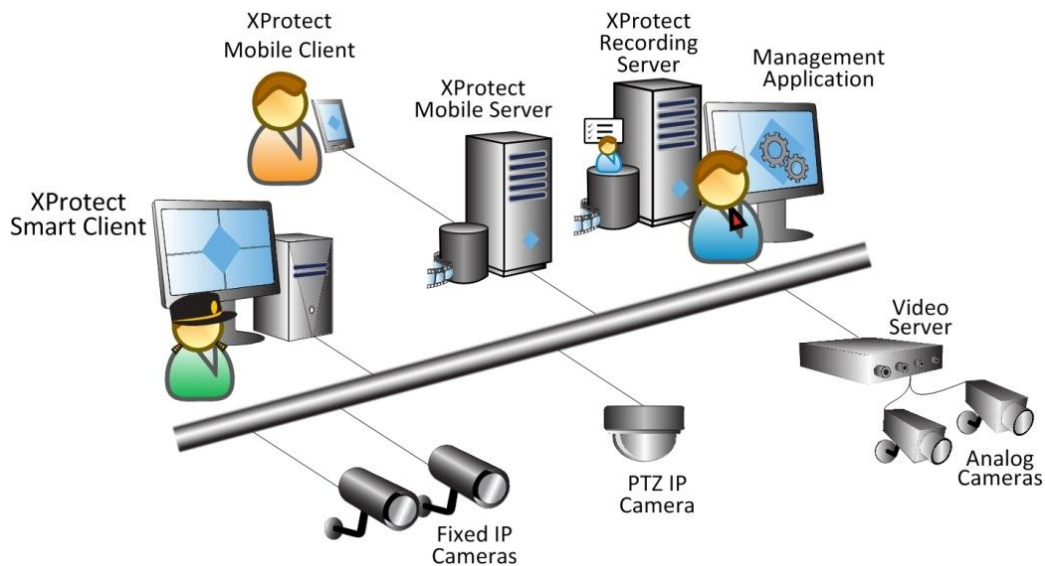
How to get started

For **existing XProtect users** who have one or more Milestone recording servers already running:

- Visit www.milestonesys.com/mobile to download and install the XProtect Mobile server component on your XProtect recording server(s) or separate server(s) dedicated for remote access
- Make sure that your XProtect Mobile server is accessible from the Internet (Contact your network administrator or your Milestone integrator if you need help with this)
- Download XProtect Mobile from the Android Market or from here <https://market.android.com/> or from the App Store on your device
- Open XProtect Mobile and add your XProtect recording server(s) in the “Servers” tab

Supported cameras

XProtect Mobile 1.0 works with all of the cameras supported in XProtect software, more than 1,000 IP cameras and encoders from almost 100 manufacturers. A list of supported hardware is found on our website: <http://www.milestonesys.com/supportandservices/support/supportedhardware/>.

System requirements

It is recommended to use a dedicated server for installations with many cameras and/or simultaneous users. The threshold for the number of cameras and/or simultaneous users depends on the specific CPU availability of the specific installation. If in doubt, we recommend that you monitor the CPU load on the machine with the XProtect Mobile server during typical scenarios for your setup. If you experience a continuous CPU load of more than 80 percent, it could impact recording services and a dedicated server is recommended to avoid overall system performance loss.
